CHANGE OF AUDITOR

This announcement is made by Prosperous Printing Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.50(4) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”).

RESIGNATION OF AUDITOR

The board (the “**Board**”) of directors (each, a “**Director**”) of the Company announces that TANDEM (HK) CPA Limited (the “**Resigning Auditor**”) tendered its resignation as the auditor of the Group with effect from the date of this announcement, as the Resigning Auditor and the Company could not reach a consensus on the audit fee in respect of the financial year ending 31 December 2022. The Resigning Auditor confirmed that, except for the matters described in the “Basis for Disclaimer of Opinion” in its audit opinion included in the consolidated financial statements for the year ended 31 December 2021 which forms part of the Company’s annual report for the year ended 31 December 2021, there are no other matters connected with their resignation that should be brought to the attention of the shareholders (the “**Shareholders**”) or creditors of the Company.

Save as disclosed herein, both the Board and the audit committee of the Company confirmed that there is no disagreement or unsolved matters between the Company and the Resigning Auditor, and there are no matters or circumstances in respect of the change of the auditor which should be brought to the attention of the Shareholders.

APPOINTMENT OF AUDITOR

The Board also announces that, with the recommendation of the audit committee of the Board, CWK CPA Limited has been appointed as the new auditor of the Group with effect from the date of this announcement to fill the casual vacancy following the resignation of the Resigning Auditor and to hold office until the conclusion of the next annual general meeting of the Company.
