

### **VOLUNTARY ANNOUNCEMENT ENTERING INTO STRATEGIC PARTNERSHIP AGREEMENT**

This announcement is made by Prosperous Printing Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis to provide the shareholders (the “**Shareholders**”) and potential investors of the Company with updated information in relation to the latest business development of the Group.

The Board (the “**Board**”) of Directors (the “**Directors**”) of the Company is pleased to announce that on 22 December 2025 (after trading hours), Jade View Limited (“**Jade View**”), an indirect wholly-owned subsidiary of the Company and IPRO LINK FINANCIAL PRESS LIMITED (“**iPro Link**”) (together, the “**Parties**”) entered into a strategic partnership agreement (the “**Strategic Agreement**”). Pursuant to the Strategic Agreement, the Parties shall form a strategic partnership for an initial term of three years to leverage the complementary strengths of both Parties, integrating the Group’s expertise in the printing industry and design services with iPro Link’s substantial number of clienteles in order to expand each other’s market influence in their respective industries and capture emerging opportunities within the rapidly evolving printing industry. As part of the collaboration, iPro Link shall entrust all of its printing and design projects it has and will have on hand to Jade View, and Jade View shall in turn commit to providing timely delivery of its services while offering competitive pricing to iPro Link.

The Board believes the Strategic Agreement enables the Group to strengthen its position in the local printing market and generate long-term value for the Shareholders.

#### **INFORMATION ON IPRO LINK**

iPro Link is a private company limited by shares incorporated under the laws of Hong Kong. It is principally engaged in financial printing services, production of announcements such as initial public offering prospectus and financial reports, and provision of venues for financial related forums.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, iPro Link and its ultimate beneficial owners are independent of the Group and its connected persons under the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited ("GEM Listing Rules").

As of the date of this announcement, according to the Strategic Agreement, the specific business cooperation and cooperation mode between the Parties in the future will be agreed upon by the Parties through further negotiation. The Company will make further announcements on the progress of its cooperation with iPro Link as and when appropriate in accordance with the GEM Listing Rules.
